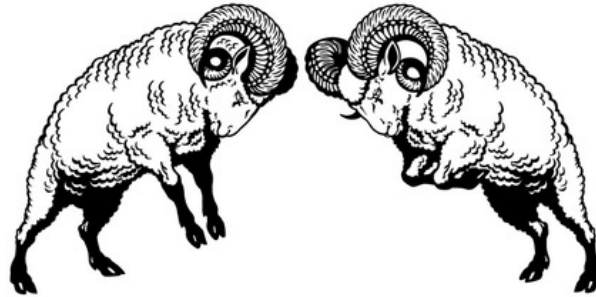

Former Senator Bob Graham Is the Truth Champion who led the effort to open the 28 Pages, proving Saudi funding and support for operatives accused as hijackers in the 9/11 attacks. HOW TO STOP ENDLESS WAR: AN APPEAL TO ALL JUSTICE MOVEMENTS

What's required is a plan on how to stop the fraudulent "war on terror" which is used to continue wars for oil and hegemony, creating a vicious cycle indefinitely until the last drop of oil is pumped. The proxy fight in Syria over who will obtain the oil pipeline route to European markets is in real danger of spinning out of control to become a nuclear war with Russia.

Contrary to some corporate media that the 28 pages does not prove Saudi government complicity with the 9/11 attacks, below is proof that the 28 pages confirm other reports that there was Saudi-U.S. collusion in causing the 9/11 attacks for the purpose of starting the Global War on Terror (GWOT) aka wars for oil, pipelines and hegemony. Unless the anti-war movement embraces and disseminates this truth, we will have endless war and possibly nuclear world war. We can no longer just demonstrate for peace. We must study the reasons for endless war and educate the population accordingly.

The 28 pages of the 2002 Joint Congressional Intelligence Committee report on the 9/11 attacks (not to be confused with the flawed 9/11 Commission report of 2004) released on July 15, 2016 gives enough evidence that, if presented in a court of law, would likely convince a jury that the Saudi government financed and arranged support and flight training for at least two of the named hijackers of flight 77, said to hit the Pentagon. **All peace and justice movements would be remiss not to join former Commission members, members of Congress and 9/11 families in their demand for a new investigation and indictments.**

These 28 pages state that then-Saudi Ambassador to the U.S., Prince Bandar bin Sultan and his wife sent \$100,000 to Saudi agent Osama Bassnan in San Diego, who lived across the street from two of the named Saudi hijackers. A long-time colleague of Bassnan named Omar al-Bayoumi, receiving money from the Saudi Ministry of Defense, paid the rent for the same two named hijackers for 18 months before 9/11/01 attacks. He paid for a translator for them because they did not speak English and arranged flight school for them. Bassnan told an FBI asset that he did more for the two named hijackers with the \$100,000 from Prince Bandar than did al-Bayoumi.

Kristen Breitweiser, who lost her husband to the 9/11 attacks, and four other 9/11 widows issued a press release stating "...when you listen to any member of our government state that the newly released 28 pages are no smoking gun – THEY ARE LYING." Their statement continued: "Zelikow blocked and then fired Dana Lesemann when she tried to investigate the uninvestigated leads in the 28 pages." Philip Zelikow was the Bush-appointed head of the 9/11 Commission. The New York Post reported that Zelikow blocked subpoenas of Saudi suspects and was thereafter made senior advisor to the Secretary of State Condoleeza Rice. Three members of Zelikow's Commission have since admitted that the Saudis were not adequately investigated by the 9/11 Commission.

Prince Bandar, also called "Bandar Bush" due to his intimate friendship with the Bush family, has a long history of doing the bidding of U.S. imperialism. Bandar engineered the illegal Iran-Contra terror, created the Mujahedeen precursors to al Qaeda to attack the elected government in Afghanistan, and is now supporting the Syrian rebels (Wall St. Journal, Aug. 25, 2013). Senator Bob Graham said: "Al Qaeda was a creature of Saudi Arabia; ...and now, ISIS is the latest creature . . . a product of Saudi ideals, Saudi money, and Saudi organizational support." Bandar's financing of hijackers to trick us into pipeline wars is in keeping with his history.

Stopping the 9/11 wars begins by exposing the Saudi government role supporting extremist Wahabbi ideology and its role in the 9/11 attacks.
