ⁱ Kennedy's assertion of control over the CIA after the Bay of Pigs fiasco was a major cause of his assassination. On April 17, 1961, about 1,500 Cuban exiles, supported by the CIA, landed in Cuba on that day. Most were quickly captured or killed by the Cuban armed forces. The CIA had lied to Kennedy in order to get his approval for the invasion. JFK swallowed defeat instead of committing U.S. troops. In recognition of the CIA's trap, he said he wanted "to splinter the CIA into a thousand pieces."

ii **Operation Northwoods** “After the Bay of Pigs botched invasion of Cuba in 1961, JFK took away planning from the CIA and gave it to the joint chiefs. He also fired the head of the CIA, Allen Dulles. In 1962 the joint chiefs were still obsessed with invading Cuba. They presented Kennedy with a plan called Operation Northwoods, which was signed by Lyman Lemnitzer and all of the joint chiefs, called for an invasion of Cuba based on a false pretext, some suggesting a fake plane, filled with college students, and blowing it up and blaming Cuba. The plan was presented in late 1962; Secretary of State Robert McNamara thought Lemnitzer had lost his mind, and Kennedy said no. He has already taken away operational planning from the CIA; now, he finds that the joint chiefs are simply a different set of lunatics.”

Dr Perry, who was experienced in interpreting bullet wounds, had inspected the wound before he performed a tracheotomy on the president. With NSAM 288, in March 1964, President Johnson signed off on battle plans for a huge air war against North Vietnam. Less than 18 months after Kennedy’s death, Johnson inserted combat troops into Vietnam, something Kennedy had never contemplated and specifically rejected eight specific times.
